- Recording and Reproduction Rights (including synchronization)
- Broadcasting Rights worldwide

B. **Territory:** The member may specify any country they wish to exclude from MCSN's administration of their rights. If no exclusion is specified, MCSN will administer the rights globally.

C. **Duration:** The rights are assigned to MCSN for its exclusive benefit as long as they subsist and remain under MCSN's control per its Articles of Association.

D. **Company's Obligations:** MCSN will pay the Assignor a share of the royalties collected from the exercise of the assigned rights as per MCSN's rules.

E. **Assignor's Obligations:** The Assignor warrants full power to assign the rights and guarantees the works do not infringe on other copyrights. The Assignor agrees to:

- Indemnify MCSN against any claims from exercising the assigned rights.
- Execute necessary documents to enable MCSN to enforce the rights.
